# OSHA 30 HOUR COURSE

## COURSE DESCRIPTION:

This course is designed to provide a variety of training to workers with some safety responsibility (e.g., construction superintendents). Mandatory Course topics to include: Introduction to OSHA, the OSH Act, General Duty Clause, Employer Rights and Responsibilities, Recordkeeping, Inspections and Penalties, General Safety & Health Provisions, Competent Person, Value of Safety and Health, OSHA Website and resources. OSHA Focus Four Hazards (e.g., Fall Protection, Electrical, Struck By, Caught in/between), Personal Protective and Lifesaving Equipment, Health Hazards in Construction, Stairways and Ladders. Additional topics will include: Power and Hand Tools, Scaffolds, Cranes, Excavations, Materials Handling Storage Use and Disposal, Powered Industrial Vehicles.

Each student will receive a copy of 29 CFR OSHA Standards for the Construction Industry Manual.
